<p><u>ASSOCIATE MEMBERSHIP</u></p> <p>This is an interim category for a maximum of 6 months for practitioners who have either trained overseas or at a course not recognised by BANT. After 6 months it is expected that full membership will have been attained via the APL/APEL submission.</p> <ul style="list-style-type: none"> One-off fee, non-refundable, of £150 which covers full APL/APEL assessment and initial registration Successful completion of the Functional Medicine Learning Zone Modules 	<p><u>APPLICATION REQUIREMENTS</u></p> <ul style="list-style-type: none"> All applicants MUST have Professional indemnity insurance for clinical practice <p>AND EITHER OF THE FOLLOWING REGISTRATIONS</p> <ul style="list-style-type: none"> Any Nutritional Therapy registrant of the Complementary & Natural Healthcare Council (CNHC) Any Dietitian registered with the Health Professions Council (HPC) Any nutrition registrant of the UK Voluntary Register of Nutritionists (UKVRN) <p>OR</p> <p>If an applicant is NOT registered with the CNHC or HPC or UKVRN and resides and works in the UK and has been in practice for a minimum of 3 years, they will need to apply for registration with the CNHC via the EXTERNAL FULL PORTFOLIO (EFP) ASSESSMENT (Application forms and supporting documentation available at: www.bant.org.uk/bant/jsp/nonBANTCNHCReg.faces)</p>
<p><u>STUDENT MEMBERSHIP</u></p> <ul style="list-style-type: none"> Initial fee of £60 and then an annual renewal fee of £20 for each year you are enrolled on your course and a student member of BANT. 	<p><u>APPLICATION REQUIREMENTS</u></p> <p>Any person enrolled on a [1] BANT recognised course or a [2] course approved by the Complementary & Natural Healthcare Council (CNHC). Recognised and approved courses are those that meet the National Occupational Standards.</p>
